Supplementary Rules

GRASS ROOTS CUTTING:

1. To be eligible to compete, a competitor must be a financial NCHA member or take out a day membership.
2. First year's NCHA membership may be purchased at half price, subsequent annual memberships will be full price.
3. The competition will be judged separately -
 - cutting (one handed) and;
 - snafflebit (two handed).
4. Competitors must NOT have won 3 NCHA affiliated cutting events in any class NOR won \$500 or more in any NCHA affiliated cutting classes. If a competitor wins 3 events or exceeds \$500 in winnings they may remain in the class until the end of the points year.
5. A competitor's run will consist of cutting two cows with two minutes working time per run.
6. The event will be judged under the same rules as all NCHA events.
7. Dress code and all other NCHA rules and policies apply as per NCHA rule book.
8. One horse one rider, however a horse may be entered in both classes with the same or 2 separate riders.
9. As per Rookies regulations the rider does not have to own the horse.

ONE-HANDED BEGINNER HORSE:

1. Horses cannot have won more than \$500 total in one-handed NCHA affiliated events as at the beginning of the point score year.
2. Horses cannot have won any one handed NCHA affiliated event.
2. Horse must be ridden one-handed and no '1 point' reining penalties will apply, however if the rider puts his/her second hand on the reins then they will automatically incur a 3-point penalty.
3. Competitors who do not make a genuine attempt to ride the horse one-handed will automatically receive a score of zero. No restriction on type of bit or saddle used.
4. Horses entered in this event cannot be entered in any other one handed event at the same show.
