**Terms and Conditions: Please read all conditions of entry, as nominating for an event confirms your AGREEMENT to all conditions of entry for Wildhorse Cutting Inc. 2024 show. Conditions of Entry Futurity:**

1. Payment in full must be received for entries to be included into the draw.
2. All Open Futurity entries are to follow NCHA Ltd Futurity rules and rulebook age specifications.
3. All go rounds will have 3 head per run, finales will have 4 head per run.
4. 2 judges will be utilised for the duration of futurity events.
5. Open Futurity event will be structured as follows:
  - 14 or less nominations, it will be a 3-round aggregate with placings being awarded highest to lowest aggregate score.
  - 15-24 nominations; 2 rounds and a top 8 final.
  - 25-50 nominations; 2 rounds and a top 10 final.
6. Wildhorse Cutting Inc. with the consent of the NCHA Executive Committee, may amend the approved time, schedule and nominated purse as per rule 2.b.
7. Non-Pro Futurity will consist of 2 rounds and will be placed on aggregate scores.
8. Practice Pen: One pen will be available with used cattle as follows, \$30 x 5 minutes x 3hd, tickets will be purchasable on the day. Priority will be given to futurity horses when needed prior to the futurity go rounds.
9. All prize payouts will be in accordance with the NCHA Ltd rulebook.
10. Wildhorse Cutting Inc. reserves the right to withhold 15% of the entry fee for administrative purposes and NCHA Ltd levies.
11. Wildhorse Cutting Inc. reserves the right to alter the program (including start and finish times) at any time prior and during the event due to entries, daylight restrictions, cattle availability, and local government requirements.
12. Wildhorse Cutting inc. will sponsor the Open Futurity final events: cattle hire, office fee and video.
13. Open and Non-Pro futurity buckles will be presented to the winners.

### **Conditions of Entry Championship show & event grounds:**

1. Payment in full must be received for entries to be included into the draw.
2. All championship show entries and events will be run in accordance with the NCHA Ltd rulebook.
3. Any person riding a horse anywhere on the grounds must be a member of NCHA Ltd. Lopers and assistants are included in this requirement. Under no circumstances are non- members to mount a horse at an approved NCHA Ltd event. Show membership is available at \$35 a day and waiver forms must be completed either by completing on I compete or at show office, a Show membership covers the rider/competitor/groom for the entirety of your event.
4. ReRun cattle: WildHorse Cutting Inc committee reserves the right to use rerun cattle if required for any event pending nominations and cattle numbers available. All Competitors will be reimbursed 50% of the cattle hire in those events, as described in the NCHA Ltd rulebook.
5. Youth event: Junior youth and Senior youth will run together, if less than 17 nominations; placings will be allocated to each category and the added money will be split 50% each. There is no office fee or entry fee for the youth, WildHorse Cutting Inc. sponsors these fees for the Youth events.
6. Wildhorse Cutting Inc. reserves the right to alter the program (including start and finish times) at any time prior and during the event due to entries, daylight restrictions, cattle availability, and local government requirements.
7. All prize payouts will be in accordance with the NCHA Ltd rulebook.
8. **NCHA Ltd rulebook – Contestants: Item 5**  
No contestants, NCHA member, or other person shall engage in any form of misconduct, verbal harassment or physical aggression toward show management, judges, NCHA employees, fellow contestants or members of the public while at an affiliated show.  
Show management has the right to immediately disqualify, refuse entry and remove from the grounds any person who violates this rule.  
No entry fees, cattle hire, camping and gate charges will be refunded and any prize money won by the offender or any horse ridden by the offender may be forfeited.
